- VTCT provides the 'Europass' certificate supplement for employability across Europe
- VTCT qualifications have international reciprocity with countries signing up to the Lisbon Recognition Treaty and there is a mandate in European legislation that these qualifications are enshrined in law for employment and mobility Article 13 Directive 2005/36/EC
- Industry lead experts are consulted with regards to technical aspects and industry requirements for qualifications development
- VTCT qualifications include environmental best practice and sustainability for the hair and beauty industry
